POSITION OF SCIENTIFIC DIRECTOR OF THE ROME TECHNOPOLE FOUNDATION ACTING AS RESEARCH MANAGER OF THE NRRP "ROME TECHNOPOLE" PROJECT N. ECS 00000024"

CONSIDERING that on 24 February 2022, Sapienza University of Rome, as the proposing party, submitted, under Article 4 of the Notice, the Project Proposal aimed at the creation of an "*Ecosistema dell'Innovazione*" (Innovation Ecosystem) called Rome Technopole involving a partnership of 7 Universities, 4 Research Centres, Institutions and Local Authorities including the Lazio Region, the Municipality of Rome and the Chamber of Commerce of Rome and a significant number of enterprises, as well as business associations operating in the region;

CONSIDERING that on 8 June 2022, at the end of the negotiation phase referred to in Article 14 of the Notice, the project "*Ecosistema dell'Innovazione - Rome Technopole*" (Innovation Ecosystem - Rome Technopole) was admitted for funding in the amount of 110,000,000 euros, and the Participation Foundation was set up as the Hub for its implementation, pursuant to Article 14 et seq. of the Civil Code and Article 7 of Presidential Decree 361 /2000, named: Fondazione Rome Technopole, entered in the Register of Private Legal Persons of the Lazio Region under no. 432, as per Managerial Determination no. G08117 of 22 June 2022;

NOTING the 23 June 2022 Decree no. 105, whereby the Rome Technopole project - code ECS 00000024, submitted by Sapienza University of Rome and its annexes, including annexe D "*Disciplinare di concessione delle agevolazioni*" (Grant Terms and Conditions) provided for by the signing of the deed of obligation between the Rome Technopole Foundation and the MUR, repertory no. 2930 of 4 August 2022, is admitted for funding;

NOTING Article 2, paragraph 1 of the Rome Technopole Foundation's Statute, according to which the Foundation promotes, without prejudice to the teaching autonomy and initiatives of the individual participants, a multi-technological and transdisciplinary pole for teaching, research and technology transfer in the strategic regional specialisation areas relating to energy transition and sustainability,

digital transformation, bio-pharmaceutical and health. The Foundation's purpose is the creation and subsequent implementation of the innovation ecosystem in the Lazio Region, in accordance with MUR Public Notice no. 3277;

HAVING REGARD TO articles 10 and 16 of the Statutes of the Rome Technopole Foundation and the resolutions of the Foundation's Board of Directors no. 36/2022 of 3 November 2022 and no. 2/2023 of 30 January 2023 and the subsequent acts of selection and appointment of the Scientific Director with Research Manager functions;

CONSIDERING the note of the PEC of 31 July 2024 in which the Scientific Director with the functions of Research Manager resigned with effect from 31 October 2024;

CONSIDERING the need to complete the three-year term of the Scientific Director and, at the same time, to meet the deadlines of the Rome Technopole project code ECS000024;

CONSIDERING the decision taken by the Board of Directors of the Rome Technopole Foundation on 16 September 2024;

The following notice is hereby published:

A procedure has been launched by the President of the Rome Technopole Foundation to recruit the Scientific Director of the Foundation, acting as the Research Manager of the "Rome Technopole" Project - ECS code 00000024 - CUP: B83D21014170006, financed by the PNRR M4C2' Inv. 1.5:

Art 1. Job description

The person selected will be in charge of the following:

- Performing the duties of Scientific Director as set forth in the Rome Technopole's Statute and according to the Project - ECS code 00000024;
- Coordinating, supervising and monitoring Rome Technopole Foundation's technical-scientific activities and their connection with the Project - ECS code 00000024;
- Performing the role of Research Manager of the Rome Technopole project - ECS code 00000024, including the coordination, supervision and monitoring of the project's activities to ensure its implementation as provided for in the granting decree;
- Promoting Rome Technopole's research, technology transfer, higher

education, outreach activities and initiatives aimed at enhancing its brand and improving its scientific attractiveness in their connection with the Project - ECS code 00000024;

- Promoting new projects aimed at the sustainability of the Rome Technopole Foundation as an achievement of the Project - ECS code 00000024.

Art. 2 Candidate profile

The person selected must have a profile of high scientific qualification and recognised international standing, with a curriculum vitae of excellence, attesting proven experience in the scientific coordination of national or international Universities or research bodies involved in research training and technology transfer, and in particular those with structured and valuable relations with companies, and with experience as Research Manager in collaborative projects financed by public bodies or the European Community which also involve the participation of enterprises.

More specifically, the selected person must:

- Have gained experience in scientific coordination activities of national or international research organisations or Universities, with priority reference to the areas related to Rome Technopole's strategic specialisation areas, i.e. digital transition, energy transition, health and biopharma;
- Have gained experience as Research Manager in collaborative projects financed by public bodies or the European Community which also involve the participation of enterprises;
- Have a scientific profile of excellence in industrial and applied research, as also proved through their scientific production;
- Have a profile of excellence in exploiting research results and technology transfer, as also evidenced by management responsibility for research projects, including industrial ones, at national and international level;
- Be part of highly qualified international networks operating in the areas of interest to Rome Technopole and have relations with internationally renowned bodies and institutions with similar aims and themes to Rome Technopole.

Art. 3. Type, duration and remuneration

The assignment is for 18 months, with the possibility of extension.

The contract may provide for a probationary period not exceeding forty-five days.

The contract may provide for a probationary period not exceeding forty-five days. For the above-mentioned position, a remuneration of 100,000 euros (one hundred thousand/00) per annum gross of social security deduction, welfare and tax withholdings payable by the employee shall be acknowledged, in addition to a possible performance allowance that shall be due upon the achievement of specific goals that shall be set and verified annually by the Board of Directors. In any case, the total remuneration may not exceed 135,000 euros (one hundred thirty-five thousand/00) per year gross of social security deduction, welfare and tax withholdings payable by the employee. The Scientific Director shall be entitled to reimbursement of documented expenses relating to the performance of its duties.

Art. 4. Admission requirements

A prerequisite for admission is a Master's degree (*LM*) pursuant to Ministerial Decree 270/04 or a Master's degree (*diploma di Laurea Specialistica*) under Ministerial Decree 509/99 or an old Academic System degree in scientific disciplines or an equivalent qualification obtained abroad.

Excellent knowledge of both Italian and English languages is required.

The following shall be considered as qualifications:

- Experience in technical-scientific coordination of national or international research organisations, Universities or research bodies;
- Experience in technical-scientific management and coordination of collaborative research projects funded by public or private entities or the European Community;
- Experience in technical-scientific management and coordination of research and innovation programmes involving the participation of enterprises;
- A Doctorate (PhD) in scientific subjects obtained in Italy or abroad.

Candidates are expected to meet the following general requirements to take part in this selection:

- Enjoy civil and political rights;
- Not have been disqualified or subjected to measures that by law exclude access to employment with public law entities;
- Have no final convictions for offences against the public administration, except in cases of rehabilitation or extinction;
- Not have been dismissed from employment by public or private law entities as a result

of disciplinary measures or for insufficient performance.

Art. 5. Application procedure and deadline

The application form (attachment A of this document) must be dated and signed by the candidate, under penalty of exclusion, and must contain all the declarations in lieu of certification and affidavit, made by the interested party under their own responsibility, pursuant to Presidential Decree no. 445 of 28 December 2000, as indicated below:

- Name(s) and surname;
- Tax code (*codice fiscale*);
- Date and place of birth;
- Residence address;
- Institution or body of affiliation, professional profile and job classification or other position currently held in companies, ethical bodies;
- E-mail address for communications pertaining to this procedure;
- Possession of the general requirements listed in Art. 3 of this call;
- Authorisation to process personal data, as part of this selection procedure, subject to acceptance of the information notice provided pursuant to Regulation (EU) 2016/679 (RGPD).

On pain of exclusion, the following must be attached to the application:

- Copy of a valid ID card or passport;
- Scientific and professional Europass CV, dated and signed, with authorisation to process data as per Italian and European data protection regulations;
- List of publications/scientific and technical products considered most significant for the evaluation and relevant to the Rome Technopole Foundation mission;
- Brief accompanying report illustrating the experience and skills deemed most significant in relation to the position to be filled, with particular regard to the mission, characteristics and peculiarities of the Foundation;
- One or more reference letters from individuals who are not partners of Rome Technopole Foundation;
- Any further documentation deemed relevant to assessing one's curricular and professional qualifications.

Art. 6. Application assessment

Applications are selected on the basis of:

- Suitability assessment based on qualifications and curriculum vitae;
- Oral interview.

The selection procedure will be carried out by a Committee appointed by the Board of Directors of Fondazione Rome Technopole, which will define the assessment criteria at its first meeting. It will take place through a comparative examination of the information declared by the candidates.

Following the evaluation, the Committee will assess whether the applications are complete and legitimate.

The Commission will select, at its sole discretion, a shortlist of up to 8 persons deemed suitable. The Commission will then summon them for an oral interview to examine and verify the declared skills to assess aptitudes and knowledge of the sector of activity.

The interview will take place online the **04 november 2024**, remotely using a videoconferencing platform. Invited candidates will be required to log on to the special link received in the invitation e-mail at the time indicated in the communication, with a valid identification document. The candidate's absence at the interview will be considered as a renunciation of participation in this selection procedure for whatever reason.

At the end of the interviews, the Commission will shortlist a maximum of 3 candidates from which the President may appoint the Foundation's Scientific Director by special Decree.

Rome Technopole Foundation expressly reserves the right to suspend, terminate or amend this procedure at any time, without any claims whatsoever in this regard on the part of the participants, and, in any case, not to proceed with the appointment if it deems that none of the candidates matches the required professional profile.

Art. 7. Publicity and dissemination

This call will be published on the Rome Technopole Foundation's website.

Article 8. Personal data processing

Note pursuant to EU Regulation 2016/679.
